**Uplighting for main entrance trees** – My Electric submitted a proposal to install uplighting for the main entrance trees. Chip Smith requested the proposal therefore with his absence this was tabled until the September meeting.

Reserve Study proposal – The Board would like at least one more bid. This was tabled.

**Yennifer Cutler, Fusion Soccer** – Jennifer Cutler was present to ask the Board if there is anywhere in Greatwood that could be used for the Fusion Soccer league, there would need to be 5 fields total. The Board requested Jennifer to

write up exactly how much area is needed, the number of participants, etc then submit to Nikkole. The Board will then assess the areas in Greatwood and the proposal presented.

**Freatwood BBQ Cookoff** – Shane Light was present to request approval to hold a Greatwood BBQ Cookoff. The Board thought it was a great idea however, has asked Shane to gather details on permitting from the County and how much area they would need. Once Shane has the information, the Board will determine where they can hold the event.

Table/Chair purchase for community building — The approximate cost for the tables & chairs for the new community building will be \$10,000. Stuart Rimes made a motion to approve the expenditure. Brian Shaw seconded the motion. All in favor. Motion carried unanimously.

Landscape Architect proposal – Enchanted Nurseries submitted a proposal for the landscape architect design, the cost would be \$3,200.00. Stuart Rimes made a motion to approve the proposal. Brian Shaw seconded the motion. All in favor. Motion carried unanimously.
